

**ORDER No. 212/2020
OF THE RECTOR
OF THE MEDICAL UNIVERSITY OF WARSAW
of 8 OCTOBER 2020**

on **completing courses and conducting examinations and diploma examinations away from the University with the use of electronic means of communication**

According to Art. 76a of the Law on Higher Education and Science of 20 July 2018 (Journal of Laws of 2020, item 85, as amended) and § 12(7) in conjunction with § 129 of the Statute of the Medical University of Warsaw it is ordered as follows:

§ 1.

1. The ***Rules and regulations of conducting test examinations away from the University with the use of electronic means of communication*** are hereby introduced as an alternative method of conducting test examinations to the examinations conducted at the University.
2. The rules and regulations referred to in Clause 1 above constitute **Appendix No. 1** to this Order.

§ 2.

1. The ***Rules and regulations of conducting oral examinations away from the University with the use of electronic means of communication*** are hereby introduced as an alternative method of conducting oral examinations to the examinations conducted at the University.
2. The rules and regulations referred to in Clause 1 above constitute **Appendix No. 2** to this Order.

§ 3.

1. The ***Rules and regulations of conducting written examinations away from the University with the use of electronic means of communication*** are hereby introduced as an alternative method of conducting written examinations to the examinations conducted at the University.
2. The rules and regulations referred to in Clause 1 above constitute **Appendix No. 3** to this Order.

§ 4.

1. The ***Rules and regulations of completing courses away from the University with the use of electronic means of communication*** are hereby introduced as an alternative method of completing courses to the completing of courses at the University.
2. The rules and regulations referred to in Clause 1 above constitute **Appendix No. 4** to this Order.

§ 5.

1. The ***Rules and regulations of conducting diploma examinations away from the University with the use of electronic means of communication*** are hereby introduced as an alternative method of conducting diploma examinations to the diploma examinations conducted at the University.
2. The rules and regulations referred to in Clause 1 above constitute **Appendix No. 5** to this Order.

§ 6.

In Order No. 99/2019 of the Rector of 30 July 2019 the appendix titled: ***Student evaluation procedure*** shall receive the new wording specified in **Appendix No. 6** to this Order.

§ 7.

In respect of any issues not provided for in the rules and regulations referred to in § 1–§ 4 the student assessment procedures shall apply to conducting examinations according to the said rules and regulations.

§ 8.

The Dean shall made decisions on any issues that need to be clarified in respect of the application of the rules and regulations referred to in § 1.

§ 9.

1. Order No. 89/2020 of 14 May 2020 on completing courses, conducting examinations and diploma examinations away from the University using IT technologies ensuring the control of the course of and recording examinations, as amended shall be no longer valid.
2. This Order enters into force as at the day of its signing.
