on _____ 2026

**on amendments to the Rules on payment for educational services provided
by Medical University of Warsaw.**

Pursuant to Article 23 paragraph 1 and 2 point 2 and Article 79 paragraph 3 of the Act of 20 July 2018 on Higher Education and Science (i.e. Journal of Laws of 2024, item 1571) in conjunction with § 10 paragraph 6) of the Statutes of the Medical University of Warsaw, the following is hereby ordered:

§ 1.

1. The following amendments are made to Appendix 1 to Order No. 191/2025 of the Rector of the Medical University of Warsaw of 25 September 2025 on the rules for payment for educational services provided at the Medical University of Warsaw:

1) in §7, after paragraph 1, paragraph 1¹ is added as follows:

“1¹. In the case of studies conducted in English, as referred to in § 1 point 1 letter b, an advance payment of EUR 1,000.00 is required towards the fees for educational services, payable within 7 days of the date of notification of inclusion on the list of persons meeting the conditions for admission to studies.”

2) In §11 paragraph 2, point a) is amended to read as follows:

“a) in full, in the event of failure to commence studies or in the event of resignation or removal from the student register prior to the start of the academic year, subject to paragraphs 2¹ and 2² concerning studies conducted in English;”

3) In § 11, after paragraph 2, paragraphs 2¹ and 2² are added, reading as follows:

“2¹. In the case of programmes taught in English, the fee shall be refunded after deduction of 50% of the advance payment referred to in §7(1)¹, if the applicant submits a written statement of withdrawal from the programme by 15 July of the recruitment year or is removed from the list of persons meeting the conditions for admission by 15 July of the

recruitment year, in which case 50% of the advance payment is non-refundable and is applied towards the costs incurred by the University for administrative work and organisational preparations related to the commencement of studies conducted in English;

2². In the case of programmes taught in English, the fee shall be refunded after deducting 100% of the advance payment referred to in §7 paragraph 1¹, if, after 15 July of the recruitment year, the applicant withdraws from the programme or is removed from the list of persons meeting the conditions for admission, or fails to commence the programme, in which case 100% of the advance payment made shall not be refundable and shall be credited towards the costs incurred by the University for administrative work and organisational preparations related to the commencement of studies conducted in English.”

§ 2.

This Order shall enter into force on the date of its signing.
