### FRAMEWORK PROGRAM OF SUMMER STUDENT PLACEMENT

#### FOR THE **THIRD** YEAR STUDENTS *OF DENTAL MEDICINE PROGRAM*

After the completion of the third year of the program the student is obliged to undertake the **practical dental and medical placement** in dental departments/offices.

Head of the dental department/office determines a scope of duties and plan for the summer student placement, appoints a supervisor and supervises student's work.

Student's absence may be excused only by a documented sick leave. If the student is sick for more than a week, it is necessary to extend the placement by a due period.

The student is obliged to keep an internship log.

The completion of the summer student placement is confirmed by the supervisor – a doctor with 1<sup>st</sup> or 2<sup>nd</sup> degree of specialisation, and the placement is approved by the head of the dental office by making an entry into the internship log.

#### PURPOSE OF THE INTERNSHIP

is to perform the basic clinical procedures in the field of dentistry and active assistance in all dental procedures carried out in the dental office. Additionally, the student is intended to broaden his/her skills regarding keeping of medical documentation and application of sanitary procedures.
